Once we have agreed use of this framework our team will check that you are registered with ESPO to use their agreements.

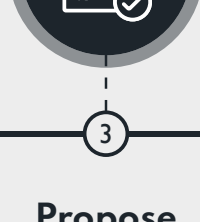
If your organisation is not registered the sign-up procedure is simple, we will introduce you to our colleagues at ESPO who will guide you through the process.

Assess and Develop

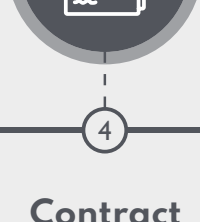
We will work with your team to fully understand your requirement and support in developing the full scope of service.

We will also need you to complete this **confirmation of award notice**, confirming the lot to be used, for submission to ESPO.

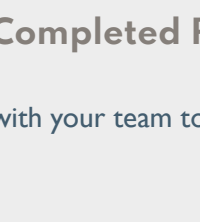
